The total enrollment of 203 students, from twelve surrounding school districts, has almost equal male/female populations. There are 20 lay teachers and one priest on the faculty.

COLLEGE CREDIT OPPORTUNITIES

Several courses are offered through partnerships with Alvernia University and Penn State University, Schuylkill Campus. Advanced Placement Exams are standardized tests administered by Nativity BVM and scored by the Educational Testing Service. Exams are graded on a 5 point scale with scores of 3-5 being considered qualified for college credit. Colleges and Universities determine whether or not to accept AP exam grades for credit. Exam dates and fees are determined by the CollegeBoard. All students who enroll in an AP course are required to sit for the AP Exam.

CLASS OF 2022 STATISTICS

The Class of 2022 has been offered a total of \$9,870,959 in scholarships, grants and awards to continue their education and have accepted \$2,308,915 of this money. Approximately 94% of the Class of 2022 will be attending a 4 or 2 year university/college, trade school or the military.

EXTRACURRICULAR ACTIVITIES

88% of our current students are members of a club, play a sport, or are involved in extracurricular activities.

Students also gain the opportunity to complete required service hours for various organizations in the community. All students are required to complete a least 100 hours of community service as a requirement for graduation.

Gifts of Stock

If you have owned a stock for more than 12 months and it has appreciated in value during that time, you would incur a capital gains tax by selling it. However, if you give that stock to Nativity BVM High School, Inc. as a gift, you avoid the capital gains tax and can also claim an income tax deduction for the full fair market value of the gift up to an amount equal to 30 percent of your adjusted gross income. Any unused deduction may be carried forward for up to five years.

Electronic Transfers of Shares of Publicly Traded Stock and Mutual Funds:

Shares of publicly traded companies and mutual funds may be transferred electronically to Nativity BVM High School, Inc.

Matching Gifts

Pottsville Catholic High School Class of 1955 Memorial Scholarship Fund

Since the establishment of the Pottsville Catholic High School Class of 1955 Scholarship Fund in 2005 (the very first Class Scholarship Fund to assist Nativity students), many of you have generously contributed to a Class Scholarship Fund designed to assist qualified students realize their dream of pursuing a Catholic education. At this time, Nativity is committed to embarking upon a much more ambitious and significant fundraising initiative.

Under the inspired leadership of Tom “Tipper” Lucas PCHS ’55 and Dr. Gerald “Jerry” Powers ‘56, Nativity has established a *Memorial Scholarship Fund* to initially honor the late Dr. Bernard M. Gillespie PCHS ’55, who was a visionary in the establishment of this endowment fund, and Sister Cecile A. Reiley ‘56. By honoring these two distinguished individuals, the school is not only recognizing the lifetime achievements of two of our most admired and respected colleagues, but also by extension, that pivotal transitional period in Catholic secondary education in Schuylkill County when Pottsville Catholic High School consolidated with St. Stephen High School to form Nativity BVM. Our plan is to recognize, each year, individuals who have made a lasting, positive impact on the Nativity community by awarding the scholarship in their name that year.

Bernie was a member and President of the last class to graduate from PCHS in 1955. He was a Magna Cum Laude graduate of Notre Dame where he





earned both his bachelor and doctoral degrees. He went on to serve as president of the Mobil Oil Solar Energy Corporation where he was instrumental in registering six U.S patents. He later joined the faculty of Marshall University where, in addition to serving as Professor of Engineering and Director of the Technology Management Master's Degree Program, he engaged in research that led to numerous publications in prestigious peer-reviewed journals that have contributed significantly to our current understanding of the conversion of sunlight to electrical energy

Sister Cecile was a member of the initial graduating class from Nativity in 1956 where she distinguished herself as a scholar and class leader. After spending a year at Immaculata College, she entered Chestnut Hill College and the novitiate of the Sisters of St. Joseph in 1957, a decision that led to a 54-year career devoted to teaching language arts to grade school children and ministering to the needs of the most vulnerable, marginalized and disadvantaged members of society at St. Malachy Parish in Philadelphia. In addition to earning a Master's Degree in Pastoral Counseling from the University of Scranton, she was a devoted mentor to generations of immigrants in the Philadelphia area as well as an accomplished artist and musician.

In honoring Bernie and Cecile in past years and others in the future, we hope to pay tribute to all of Nativity's graduates who, over the intervening years, have made major contributions to society and have contributed significantly to the stellar reputation of this outstanding educational institution. Nativity has established itself as one of the most prestigious Catholic High Schools in the State of Pennsylvania with 90% of its graduates going on to higher education. This past year alone they were collectively offered more than \$9,870,959 in higher education scholarships and related academic awards averaging approximately \$152,000 per graduate.

Unfortunately, parishes can no longer adequately subsidize Catholic education. Tuition is now \$7,000 a year. By today's standards, Nativity's early years of a free, four-year education can be valued at \$25,000. Because of these escalating costs, many prospective students who aspire to attend Nativity can no longer realize their dream. Our goal is to raise at least \$200,000 in an effort to help offset some of these costs for future generations of students. Having benefitted by a Nativity education, we are hopeful that many of you will feel that it may be an ideal time for those of us who can afford it, to "pay-it forward".

Many of us are now at a time in our lives when it is normal for us to consider what our legacy should be with respect to the generations that follow. A small group of generous benefactors of the School have already donated more than \$80,000 of the \$200,000 goal. It is hoped that you may feel similarly inspired to join that group and contribute whatever you feel appropriate. There are very few charities in life that are more worthy than contributing to the education of the next generation of student scholars and national leaders.

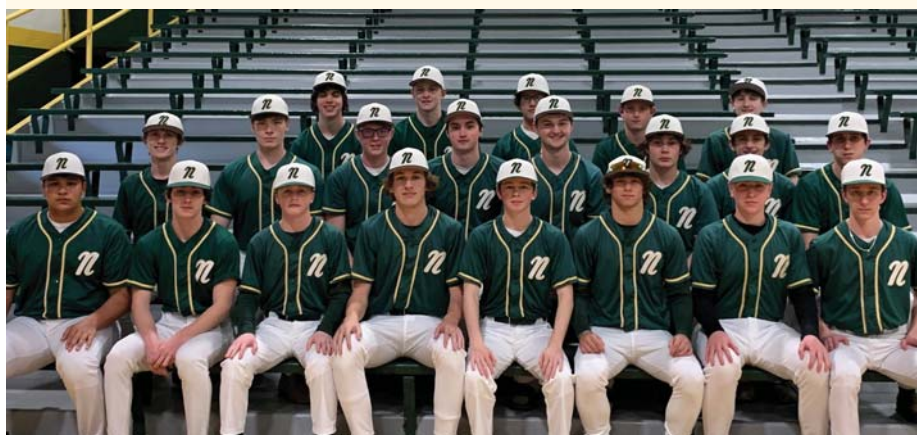

Businesses in the state of Pennsylvania can reallocate money from their state taxes to tuition assistance at Nativity BVM High School, Inc. The Educational Improvement Tax Credit (EITC) program allows businesses to receive a 90% tax credit (if donating for two consecutive years), and families at Nativity receive tuition assistance. Individuals:

Turning Taxes Into Scholarships

If you are an individual paying Pennsylvania state income taxes, you can turn your tax dollars into need-based scholarships for Nativity BVM High School students. Pennsylvania provides a 90% tax credit (if donating for two consecutive years) to individuals who donate funds for Catholic School education. To participate, an individual must meet one of the following financial criteria:

Individual income of \$200,000 or more in each of the two previous years OR
Joint income of \$300,000 or more in each of the two previous years OR
Net worth of \$1,000,000 or more excluding your primary residence.
